The Pain of the Change

Strategic planning to some is a once a year event that culminates in a nicely bound set of objectives that sits on the shelf the rest of the year collecting dust. At Cal Farley's, strategic planning is ongoing and a necessary driver of innovation and progress.

I've been with Cal Farley's for 20 years now, almost 12 of which have been in my current role as President and CEO. In all of my years here, there is one thing that remains constant and that is *change*.

This is not unique to Cal Farley's. Most organizations experience constant pressure to change. The main reason for this is the demands of the *stakeholders* who expect certain things of us depending on their frame of reference: those we serve, those who fund us, and those who hold us accountable.

The most important stakeholder group is our clients, the children and families we serve. They call us in a crisis, and what they need from us is help in whatever form we can deliver it... this requires commitments on both sides.

Funders are stakeholders. If we accept their funding, we respond to their expectations. And, regulators are stakeholders. If we are to operate legally, we follow laws, rules, and standards.

Alumni are stakeholders in several ways; as those once served by Cal Farley's, donors, advisors and even governing board members!

Each one of our board of directors is a stakeholder. Their obligation as a group is to hold me accountable for the fulfillment of our mission while ensuring quality of care, legal and ethical management of our finances and employment practices, and our fundraising practices.

No decision we make in <u>any</u> area is arbitrary, and sometimes we shift gears because the way we've always done it may no longer be effective.

Several years back, we began evaluating our organization with an employee centered tool called the Survey for Organizational Excellence. Over the years, I have seen several consistencies. First of all, most employees seem to be in sync with our mission. Another is our strategic orientation –that is, we were always open to pondering different and better ways of doing things.

Ironically, we also score high on resistance to change.

This means that the idea of change feels good to us, but the reality of change is uncomfortable. That is normal because in the absence of a perfectly clear picture of the future, people tend to hang on for dear life to what they know. Progress and innovation can be scary.

One of the world's most famous innovators, Steve Jobs, had a theory about that. He said, "You can't connect the dots looking forward; you can only connect them looking backwards. So you have to trust that the dots will somehow connect in your future. You have to trust in something."

What I trust about Cal Farley's is our tendency to do the right thing, at the right time, for the right reason, in spite of the *pain of the change*. And that, by the way, is completely in line with the famous Cal Farley quote, "It's where you're going that counts," our 75th anniversary year tag line.



We've done a pretty good job over the years managing through change: becoming co-ed at Boys Ranch; working closer with families, starting alumni support services, expanding our community centered services, and adopting a more strength-based model of care.

I can't tell you exactly what the future will look like, no one can. What I feel certain about; is that that more change will happen. What I also feel certain about is that we are going to continue taking care of as many children and families as we can, in the best way we know how, within the resources we have.

While our mission and our values will transcend time, our approaches will <u>always</u> be adjusted to fit the needs of our children and families and the expectations of our primary stakeholders.

For Skylar, the first year after high school was one of learning the ropes of adulthood, self-

discovery and reliance on God. Skylar notes that one of the main things she learned after leaving Boys Ranch is that life is ever-changing. "I'm big on constants and I've had to learn some adaptability." Part of that adaptability involved moving from a stance of self-reliance to embracing a dependency on God. She realized she needed a spiritual foundation to weather the storms that are an inevitable part of life. "At first I tried to do things on my own. I separated myself from God. I finally realized that life's journey is impossible without faith. When I rebuilt my spiritual life, I realized I was never supposed to be alone."

Skylar is very involved in the youth group at First Baptist Church of Amarillo and is readying for a mission trip to Hungary later this summer. According to Skylar, the mission's goal is to reinforce the faith of new churches there. "Most of what we hope to accomplish is evangelistic work and just spreading the true word of God. We want people to know that through the darkness of this world there is an everlasting light."

Skylar's spiritual maturity, her engaging smile and her natural propensity to help others, make her a natural role model for those around her. She has served as a peer mentor for other residents at the Alumni Support Center and never seems to tire of putting the needs of others ahead of her own. When asked what advice she would give to young people just leaving Boys Ranch, Skylar stated, "No one can take success from you but yourself. Every day you choose to be a winner or a loser. So, which will it be?" Skylar's daily choice is obvious.

It's been a joy to watch her grow into the young who lights up a room with her smile and inspires us all with her faith. Skylar, we are so thankful to have you as part of our Cal Farley family.

Here's a quick rundown of the weekend's events.



We just finished another fiscal year and it would be a good time to see how we're doing. Not so badly! The past year has been a banner year for the Association in some ways...an okay year in others. First let's consider where we need to improve. Truth is, we can always improve everywhere, but some things need more attention. Our actual membership is down. We've had fewer gatherings and attendance has

not been as great. You ask, "What can I do about that?" If you are not a member you could pay the annual dues of \$20. That's a good minimum. We've done some very good things this year. We contributed over \$21,000 towards building a Veterans Memorial at BR which was dedicated in November. Over 50 former residents are recognized on the Veterans Wall. If you served you are encouraged to have your tile placed on the wall. New tiles will be added prior to Veterans Day. The Association helped 11 families in crisis situations and provided scholarships for a dozen students. We provided awards for Boys Ranchers showing livestock and prizes for Christmas Scenes at the homes at BR.

We recognized the Rattan's as distinguished staff and Andy Justus as distinguished alumnus in 2015. This year we will be recognizing the Sharps and Jimmie Boatwright as distinguished staff and alumni. The Association has grown the foundation to half a million dollars, which includes over \$180K in scholarship endowments. One fact that should be noted is that 84% of the net revenue has gone directly to our mission efforts of providing crisis support, scholarships, helping alumni and supporting Cal Farley's. You have done some very good work this year. You are doing well. Could do better, but moving in the right direction.
