

The Presidents Corner

"New Year Resolutions"

Many traditions are associated with New Years Eve: singing Auld Lang Syne, kissing at midnight, watching the ball drop at New York's Time Square and of course making resolutions. About 88% of American adults make such resolutions every year with losing weight and getting into shape leading the way as the most popular resolution. Less than 20% of those resolutions are maintained for more than six months.

My New Year's ritual is goal-setting. Each year I review my last 12 months—the good, bad and ugly—and make financial, relational, professional, spiritual assessments. I review the goals I set a year ago and evaluate my progress. On January 1, 1999, one of my goals was to keep a daily journal, something I have done every day since then—filling a journal about every six weeks. The written record allows me to walk back through the year and review.

How are these goals that different than resolutions? Goals are clearly stated in writing and are followed with strategies and tactics for follow-through. Goals have a measurable outcome and therefore an ongoing assessment. Large, overarching goals are fulfilled by daily and monthly objectives which are reduced to writing and checked off as they are accomplished. It is a coldly objective, strategic approach to fulfilling one's purpose and mission in life—a concept that is not always popular in the Oprah Winfrey era in which people seem to be more concerned about feelings rather than results.

Your association has embraced an intentional, goal-oriented approach to building an effective organization and fulfilling its mission to carry on the work of Cal and Mimi Farley by supporting each other through a professional network of alumni. The work of the association is carried out through its committees, each of which has developed goals for the current year. These goals have been adopted by your board of directors and collectively, these committee goals represent the annual goals of your association.

Membership Chairman Scott Carriker is working to double paid membership this year. He is working proactively with the Cal Farley's organization to develop an effective approach to maintaining accurate databases for both entities. Our goal is for the alumni association to become part of the lives of our alumni brothers and sisters, rather than something tied to a single annual event. Scott and his committee continue to work toward establishing additional local chapters and define the relationship between these affiliates and the national association. Special Needs Chairman Michael Rogers is building from his committee's last year's completed goals. Special needs policies and procedures were developed and a number of our brothers in need have benefited. In the normal order of things, we turn to family when faced with insurmountable calamities. Many of us do not have that traditional family network, and the alumni association can stand in the gap and be that family. In November, we were able to pay for the funeral expenses of Stuart Wells, an alumni brother who was taken from us after an intermittent battle with cancer. Michael has worked with the Cal Farley organization to ensure that we do not duplicate efforts. Michael is also forging an effective partnership with Cal Farley's concerning the Boys Ranch Cemetery.

Doug Brady has a goal to raise \$10,000 for our **Scholarship Fund**. The board has earmarked \$6,000 of operating funds for scholarship purposes, so we can move ahead and provide this service. Scholarship support for alumni through the Cal Farley's organization is plentiful. Donors love to support scholarships. Thus, the Cal Farley organization has a substantial scholarship endowment. However, this endowment does not touch the next generation of Cal Farley's boys and girls—in essence the Cal and Mimi Farley's grandkids—your children. This goal, when realized, will help you educate your children.

Bob Sarpalius chairs the **Budget and Finance Committee**. His goals build on last year's completed goals—maintaining sound, auditable financial accounting using generally accepted accounting principles and airtight internal controls. This financial piece is critical to our development efforts. It is also vital in maintaining total financial transparency in handling your association's resources. His partnership with the membership committee is crucial to that committee's initiatives.

Aaron Alejandro, Development Committee, is developing new fundraising strategies to support association enterprises. He is developing strategies and tactics for securing significant gifts with a larger goal to build a permanent endowment to support our work. Aaron will tell you that development is more than just fundraising; it's an opportunity to articulate key messages and develop long-term mutually beneficial relationships. His goals reflect that. Another of his goals is the development of an Alumni Chamber of Commerce, through which alumni can do business with other alumni.

Britt Hammond chairs the **Annual Meeting Committee** and is already engaged in footwork for the 2007 rodeo reunion and meeting. His goals include improving on a very successful 2006 annual meeting. He is working on hotel and facility arrangements, considering new activities, while using the assessment of the 2006 meeting as a tool to guide his committee's work.

Bill Sarpalius provides leadership for our **Executive Committee** which provides coordination amongst all of the committees—and helps to keep committees focused on their respective annual goals.

Where have you been in 2006 and where are you going in 2007? What are your goals? What is your plan? Are these goals in writing? If being a part of a vibrant organization with a mission that matters is part of your 2007 goals, consider engaging with your alumni association. Together, we will accomplish great things in 2007 and for many years to come. Together, let's realize our goals for 2007 and set higher marks for 2008 and for each subsequent year. We are building a future for each other and for generations of alumni yet to come. Let's make 2007 a happy new year.

Russell Guest (06) was in the play production *The Triangle Factory Fire Project* put on by Amarillo College's Experimental Theatre in October.


Cross-Country State Meet
